Below is a eulogy that we compiled for Lyall's celebration of life which was read out in our absence. As the ceremony was conducted on the same day as our Xmas lunch for ACV/GARDS and we were unable to attend. We would like to share this with our readers. Lyall passed away on the 15/11/2014.

On behalf of the Asbestos Council of Victoria/GARDS committee and members we would like to say how saddened we are that Lyall has lost his battle with mesothelioma. We are very disappointed we cannot be here with all of you today.

We first met Lyall in 2010 and the relationship between us grew from our first meeting and we became quite close over the years - ringing each other and comparing notes, ideas and thoughts.

Lyall was a tireless worker behind the scenes for the asbestos cause - he was a quiet unassuming gentleman - he had joined just about every support group around Australia. We were lucky enough to meet him and he joined us too.

Lyall came to our events and he

bought Gary along a few times too! It was always good to see them and we always had plenty to say to each other.

When Lyall's and our relationships became closer in the last few years he voiced his opinions on many things

Lyall had a strength and determination which drove him to push for research - which he was passionate about, and making people aware of the dangers of asbestos. When he told us that he had decided to donate his mortal remains to science we were so proud of him. Lyall never thought of himself as a victim (he hated that word) always as someone suffering from asbestos disease. He never liked "victim" as he believed that the word victim made it sound like a sense of hopelessness - of not being able to do anything about the situation and not in control.

Of course everyone he met - he made sure that he was doing everything he could to change the outcome for others, and he was no "victim" but a "champion" of the cause.

Asbestos Council of Victoria/ GARDS considers themselves very honoured and proud to have known such a wonderful man whom we considered a friend of our organisation.

Lyall was a staunch supporter of

Asbestos Council of Victoria/ GARDS and was very close to me (Vicki) and other members of our organisation - I will miss him very much and our long talks on the phone about all sorts of issues. Many in our group were sadden to hear of his passing. Lyall was a consummate gentleman and one of the finest men I have ever known.

I don't have to tell you all that Lyall battled many adversities with his illness over the time since his diagnosis - most times his illness just seemed to get in the way of what he wanted to do.

Gary, we wish we could be here today to give you a big kiss and cuddle but our Xmas lunch for our members has got in the way of being able to be with you all today and exchanging personal stories and happy memories about Lyall . I know Lyall would have liked to have been with us for the ACV/GARDS Xmas lunch today - he enjoyed coming and being with us and was intending to come if well enough this year.

We hope you can feel the love we have for you Gary our emails & phone calls between us have been personal and at times very emotional. After more than twenty years though you will have many happy memories of your life together and can feel very proud of the legacy Lyall has left us all - he has left us with a bond that has united us all.

Finally we would like to thank you so much Lyall and Gary for allowing us to be a part of your lives in some small way - we were very privileged and honoured to have known Lyall. We hope Gary that you will keep contact with us and will still be a part of our group for many years to come. Lyall's membership badge has been put up on our Memorial Board and was on display at our Asbestos Awareness Day event on Friday 28th November where we did a Vale to Lyall so our community could know what a kind gentleman Lyall was. Lyall will be sadly missed by all who knew him - but will never be

IN AUSTRALIA

Bins full of suspected asbestos sit on property while council wrangle over who is responsible - Therese Allaoui From: Mordialloc Chelsea Leader March 23, 2015

FOR three months Tasha Strelkoff has lived with bins full of suspected asbestos on her property while two councils wrangled over who should clean it up. Ms Strelkoff came out of hospital just before Christmas to find four City of Whitehorse wheelie bins, filled to the brim with construction material, dumped on her Mordialloc property. Landlord Brad Griffin said his calls to Whitehorse and Kingston councils were met with refusal to deal with the potentially dangerous bins. Kingston Council even threatened to fine Mr Griffin up to \$2000 in a January letter, which ordered him to "remove four refuse bins suspected of containing asbestos from the property". More than three months later, Ms Strelkoff said she was angry the council had washed its hands of the mess, which could be a danger to herself and passing pedestrians. "It's a council issue that someone has dumped some possibly really toxic stuff in the front lawn," Ms Strelkoff said. "It's a concern because it could be lethal. If anyone decides to walk past and flip the lids open, or if a wind gust decides to flip the lid open, there's a danger to it."

The creator of the toxic legacy not only pumped loose-fill asbestos into his own home but stored bags of the dangerous substance on the property.

The House Detective: Asbestos inspection incomplete - Barry Stone, Certified Building Ins

Pector March 21, 2015

DEAR BARRY: We own a home that was recently flooded. Now the interior must be stripped to the framing and rebuilt. An environmental inspector was hired to determine if there is any asbestos. He found none, so the contractor proceeded with demolition. While removing plaster, he uncovered heating ducts that are insulated with asbestos. That material was damaged in the process of opening the walls, so now that contractor must report this to the air quality control board and to the Occupational Safety & Health Administration, and we may be subject to fines. The contractor says the asbestos insulation should have been reported by the asbestos inspector, but the asbestos inspector says he was only required to test surface materials. Who is right? — Art

DEAR ART: The asbestos inspector's responsibility was to determine all possible sources of asbestos on the property and to advise you accordingly, prior to demolition. Whether he was limited to testing surface materials or not is irrelevant. The location of the air registers should have indicated to him that there were air ducts inside the walls.

Dumped asbestos removed swiftly from Osborne site, Renewal SA says - Fri~20~Mar~2015,~ABC~News

Government agency Renewal SA says tonnes of dumped waste including asbestos has been swiftly removed from a site at Osborne in Adelaide's north-west, to ensure there is no public risk. A union made the danger public when it found out about the illegal dumping and notified the Environment Protection Authority (EPA) and Port Adelaide MP Susan Close. A Renewal SA official said the waste was dumped on former defence land it now owned at Osborne. "We acted as soon as we were notified, arranging for a contractor to remove the waste for appropriate disposal at a licensed landfill," a spokesperson said. "This work [was] supervised by a specialist environmental contractor."

Asbestos feared dumped at popular Adelaide leisure spot near Port River - $Fri\ 20\ Mar\ 2015,\ ABC\ News$

A union official says waste dumped in Adelaide's north-west, close to the Port River, appears to include asbestos. CFMEU official Dave Kirner checked the area at Osborne after a tip-off and took photographs of the dumped material. Environment Protection Authority (EPA) officers have since sealed off the area and taken samples of the dumped material for testing. The union said the area was popular for dirt and quad bike riding, four-wheel drives and other leisure activities. Mr Kirner said there appeared to be roof or fence sheeting in the dumped material and he urged people to keep away.

Lismore man fined for dumping asbestos - 19th Mar 2015 2:03 PM. The Northern Star

LISMORE City Council has fined a 36-year-old Lismore man \$4000 for dumping asbestos, and are sending a strong warning to anyone

else thinking of illegal dumping. Council said the man dumped 220kg of asbestos-contaminated material on Boatharbour Road and was tracked down following the thorough investigative work of a Council Compliance Officer. Council's Manager Development & Compliance Peter Jeuken said the material had to be removed by a licensed asbestos contractor and would only have cost the man approximately \$120 to dispose of legally as a result of EPA subsidies.

"People are trying to avoid paying quite reasonable fees, only to be lumped with a large fine, and in the meantime they are putting people and the environment at risk," Mr Jeuken said. "The material samples taken at this particular dump site were sent for analysis and tested positive to two types of asbestos.

Asbestos claiming bush lives - SALLY CRIPPS 19 Mar, 2015

DEBRIS scattered across the landscape in the wake of Cyclone Marcia has set the asbestos alarm bells ringing for people cleaning up in central Queensland, but those with long-term knowledge of the dangers associated with the product are urging people in the bush and on farms to be on the lookout for it in their daily lives. More cases of illness from rural areas are diagnosed every day. Lined shearers quarters, broken cement pipes lying exposed on dam banks or used to feed stock with, hay sheds with flaking asbestos cement roofs - examples of the many ways country people are still at risk of exposure to the deadly product. Elisha Parker was introduced to the pain that asbestos is wreaking on rural families in 2002, when she started work with law firm Turner Freeman, which deals specifically with damage caused by the product. "Asbestos is in so many industries - it's startling," she said. "It's common to associate it with buildings, but banana farmers have been affected by bags they covered their fruit with, for example, and their wives inhaled fibres when they were washing dirty clothes.

Another Mr Fluffy home confirmed in the Hume Shire - March 17, 2015 ACT News

Another Mr Fluffy home has been discovered in the Hume Shire – halfway between Wagga and Albury. Just last fortnight the Heads of Asbestos Coordination Authorities in NSW confirmed a Queanbeyan home had been confirmed to contain Mr Fluffy as part of an independent investigation into loose fill asbestos in NSW. The latest discovery brings the total number of affected homes across NSW to 61. As of March 12, 2,186 premises across 26 Local Council areas have registered for the free sampling service. Of these, 1,284 properties have been tested with 1,280 samples determined to not contain asbestos.

Asbestos victim wins right to claim compo - 16 March, 2015 Ben Hagemann, Australian Mining

A former Gove alumina refinery worker has successfully claimed \$425,000 in compensation for malignant mesothelioma, which developed as a result of asbestos exposure during the 1970s. Zorko Zabic, 74, was denied compensation by a Supreme Court ruling in January as he did not make the claim within the period outlined in the statute of limitation. Zabic began to experience chest pains in January 2014, after a typically long latency period for that type of cancer, but it was ruled a year later that his claim was statute-barred as it should have been filed before 1987. Justice Barr said at the time he was satisfied that Zabic's condition was caused by unprotected exposure to asbestos dust and fibres during his employment as a result of negligence by Alcan Gove (purchased by Rio Tinto). However, Justice Chief Riley has told the Court of Appeal that Zabic's appeal has been granted. Zabic's lawyer Roger Singh of Shine Lawyers said the decision would pave the way for other asbestos victims in the Northern Territory previously denied the ability to make similar claims, ABC reported. "Today's decision is a win for workers, a win for their families and a win for humanity," he said last week. A spokesman for Rio Tinto said although company did not own the refinery at the time of Zabic's employment, they had sought to resolve the matter fairly as owner of the site

Submissions sought on loose fill asbestos action plan - 11 Mar 2015, ABC News

The head of the taskforce investigating Mr Fluffy asbestos in New South Wales suspects there are more than the three houses identified with the issue. The properties, in the Berrigan Shire and at Queanbeyan, have been identified through a free testing program that has been running since last year and on offer in 26 local government areas. Loose Fill Asbestos Insulation Taskforce Chairman, Dave Owens, says more than 2000 people have sought free tests, with over 1,200 tests completed. Prior to the free testing program starting, houses were identified in Queanbeyan, Parramatta, Manly, Lithgow, Yass and Bungendore as being affected by Mr Fluffy. More sick BHP workers expected to come forward after damages payout -12 Mar 2015, ABC News

Lawyers for a terminally ill ex-Newcastle BHP steelworker, who has won the right to keep a massive damages payout, say they expect more sick workers to come forward. A court has dismissed an appeal by BHP Billiton against the \$2.2 million payout awarded to Steven Dunning, 54. He has mesothelioma after inhaling asbestos dust while working in Newcastle in the 1980s. The Court of Appeal agreed BHP had failed in its duty of care. Mr Dunning's lawyer Joanne Wade said she has no doubt other workers are sick. "Asbestos was there and it was used in the steelworks and, in reading the decision of the judge and the Court of Appeal, BHP were negligent in protecting workers, like Mr Dunning," he said. "So I am sure that there will be other workers, and there will be other people diagnosed with lung illnesses arising from exposure at BHP at Newcastle." Ms Wade said the appeal court judges unanimously concluded the company had breached its duty of care. "If you read the decision of the judge, he did make findings that BHP did know of the dangers of asbestos, and BHP knew it could cause mesothelioma," she said. "They did not take precautions to protect people, such as Mr Dunning."

Asbestos confusion mounts with conflicting reports on dates - Christine Mckee 11th Mar 2015

WHEN Colin and Lenore Lindsay had their new home built in 1970, they were assured the new Hardiflex product being used to clad the house contained no asbestos. "We were told by the builder the building sheets were not the old Fibrolite sheets like they used on my parents' house, built by dad in the 1940s. "But now we are being told any house built before 1990 in some reports and 1985 in others contains asbestos and needs special and expensive handling." A testing laboratory was established at the Department of Agriculture on 25 Yeppoon Rd by Octief, which can test samples. Current legislation means any fibro material prior to 1989 could contain asbestos but according to Octief asbestos services manager Brendan Worrell, it is impossible to put a blanket statement around dates. If in doubt, double wrap a small sample - a 50 cent size is enough - and take it to the laboratory for analysis. "People do need to take the necessary precautions but if they are a bit nervous, we have people who can come out and take the sample," Mr Worrell said. Cyclone Lam: Galiwinku tent city nears completion; asbestos to be stored 'off the community' - ABC March 2, 2015

ACT Health contractors unearth asbestos on 'healing farm' site -January 15, 2015 - Canberra Times

Contractors hired by ACT Health to work on a government-owned property near Tidbinbilla have potentially been exposed to asbestos on a site reserved for an indigenous bush healing farm. Workers may have come into contact with asbestos despite warnings from the long-term resident property manager Ben Broers that the area they were working in was contaminated. Mr Broers has subsequently had his contract terminated by ACT Health and has been asked to sign a confidentiality agreement. The directorate started building works two months ago at Miowera, a property in the Tidbinbilla Valley. The government bought the land in 2008 to build an indigenous drug and alcohol rehabilitation service - to "reconnect Aboriginal and Torres Strait Islander peoples to land and culture, using participation in land management activities and programs". The 320-hectare site has extensive asbestos contamination due to remnants of two bonded asbestos sheet houses that burnt down in the 2003 fires, the asbestos sheeting from the Old Cotter Pub, and other asbestos refuse from around the region which has been dumped in a landfill gully. Hundreds of metres of asbestos fencing have also been

bulldozed over the years. leaving asbestos footings submerged in the soil.

ASBESTOS pieces have been found in three separate spots around popular beachside town Apollo Bay. But testing carried out by the Environmental Protection Authority last week found the asbestos had not contaminated the soil itself, making the clean-up process easier. Chunks of asbestos sheeting — ranging in size from 2cm to 5cm — were uncovered at the Apollo Bay Golf Club, Pony Club and an area of the foreshore next to a playground after four days of testing. EPA chief executive Nial Finegan said a member of the public had expressed concern about fragments of asbestos in the soil early last week, sparking action by the authority. "EPA, on a precautionary basis, quickly ensured the soil was contained and then conducted testing on the fragments and the soil to determine whether there was any asbestos present," Mr Finegan said. Decades-old Kenbi land claim held up by \$32m clean-up bill for asbestos and pollutants hazard - Nadia Daly and James Dunlevie 12

Australia's oldest unresolved Aboriginal land rights claim is facing a huge asbestos problem which the Government says will cost almost \$32 million to clean up. The Kenbi land claim was lodged in 1979 and 36 years later has still not been fully resolved.

The claim covers the Cox Peninsula, west of Darwin, which had been used by the Commonwealth Government for over 70 years for communications and defence purposes during WWII, with a lighthouse and other government buildings spread over 4,750 hectares of land. A report by the Department of Finance submitted last month stated that buildings and their surrounding areas on the land are harbouring dangerous levels of asbestos, pesticides, heavy metals and other toxic pollutants, which "pose a significant risk to human health" and represent a "liability for the Commonwealth". The area has also been used as a dump for decades, with building debris from Cyclone Tracy in 1974 being offloaded there.

Mr Fluffy asbestos: Cabinet papers show decade of warning and inaction Craig Allen 1 Jan 2015 - ABC News

Cabinet papers have revealed the Federal Government was warned as far back as 1968 about the risks of loose-fill asbestos insulation, but did nothing to stop it being used in Canberra homes for a decade The National Archives of Australia released cabinet submissions and minutes of the third Hawke government, covering 1988 and 1989 - the period when the emerging asbestos crisis was being addressed. The product known as Mr Fluffy insulation was pumped into the roof spaces of more than 1,000 Canberra homes between 1968 and 1978. Despite a Commonwealth-funded clean-up program in the 1980s and 1990s, remnant asbestos fibres were still being found in the wall cavities and sub-floors of some properties. The cabinet papers revealed two government departments were alerted to the potential risks to householders in 1968 - the year the Mr Fluffy company began work on homes in the Canberra region. "Whilst the government was not in any way involved in the asbestos installation process, the then departments of interior and works were advised of the possibility of a problem for house occupants by the then health department in 1968," cabinet minutes from July 1988 said. "No action was taken to ban the substance, although action was taken to control occupational exposure.'

James Hardie Proposes Compensating Asbestos Victims in Installments - Jan 22, 2015 Lorraine Kember

Asbestos victims who filed claims against James Hardie Industries, an Australian building materials company, may never live to see their legal compensation if a court approves the manufacturer's plan to pay claimants in installments, and not the traditional lump-sum payments. The reason for the installment plan: Hardie's Asbestos Injuries Compensation Fund is headed toward a \$184 million cash shortfall in 2017 because of a spike in mesothelioma claims. If the Supreme Court of New South Wales (NSW) grants approval, the installment plan will take effect July 1. Advocates for those affected by mesothelioma are outraged by the company's proposal because the average life expectancy for people diagnosed with the asbestos-related disease is less than two years. Those patients need the lump sum of their compensation as quickly as possible to pay for expensive treatments, lost wages, expenses not covered by insurance and other costs.

"Asbestos victims don't die in installments," Asbestos Diseases Foundation of Australia President Barry Robson wrote in a press release. "They don't lose the ability to work or care for themselves in installments, yet James Hardie wants to see them compensated in that way."

The popcorn nobody wants: How to remove your own popcorn ceiling - Lisa Greim Special to The Denver Post 03/21/2015

Like cork walls, mirror tiles and avocado- green shag carpet, acoustic ceiling texture was all the rage in the 1970s and 1980s. Builders of thousands of new Colorado homes relied on it for a quick, inexpensive finish. The most common complicating factor in popcorn ceilings is asbestos. Until it was banned in 1978, asbestos was used in ceiling texture, and disturbing it creates a health hazard. Paint and drywall contractors will require that your ceiling be certified free of asbestos before they move forward. Cost guides provided by Golden-based HomeAdvisor estimate that popcorn ceiling removal projects in Denver cost an average of \$1,500. Professional asbestos abatement more than doubles that cost, to an estimated \$3,300. If your home dates from the early 1980s or earlier, wet down a small patch of ceiling, scrape some texture into a plastic bag and send it to a lab for asbestos testing.

Tropical Cyclone Pam: Rescue teams remove over 100kg of asbestos from Port Vila's central hospital - Hilaire Bule in Vanuatu, wires. 20 Mar 2015

Australian rescue teams have removed over 100 kilograms of asbestos from Port Vila Central Hospital in the wake of Tropical Cyclone Pam. Gary Bailey from Australia's Urban Search and Rescue team told Radio Australia's Pacific Beat program the asbestos was found mostly in sheeting and roofing. "We spray (PVA) glue onto the asbestos to bond the asbestos fibres, we then wrap that asbestos in plastic and dispose of it in a proper manner," he said. "So our crews came with a lot of glue and a lot of sprayers to allow us to do that. "We've been going into various parts of the hospital and some primary schools today and rendering as much asbestos as safe as we can." Left undisturbed, asbestos poses no health risk but because of the damage sustained by many buildings during the cyclone, the asbestos needed to be removed immediately.

"Asbestos anywhere out in the open is a dangerous thing," Mr Bailey said. "When it's been broken up in the way it has by the storm, the fibres that come off from the asbestos, it's very dangerous to human beings and they can cause some very serious diseases. "So we need to clean it up as best we can."

Man was exposed to asbestos during wartime - Tuesday 17 March 2015 in News - Daily Echo

A WINCHESTER man died of mesothelioma after what is thought to have been one of the longest incubation periods of asbestos exposure in the Hampshire area. Philip Hall died at his home in Stoke Charity on June 13 as a result of malignant mesothelioma, while waiting for admission to a hospice. The 94-year-old retired chemist is believed to have been exposed while working at a munitions factory in the early 1940s. His daughter, Elizabeth Howlett Hall, said: "He very often used to tell us as children that heating in such a situation could not be by gas or open fire because of the rather large explosive components, so heating was by steam, pumped through the building through asbestos pipes." Simon Burge, deputy coroner for central Hampshire, recorded a verdict of death due to industrial disease.

EXCLUSIVE: Deadly asbestos hiding in nine out of 10 British schools - Lucy Johnston Mar 15, 2015

ALMOST nine out of 10 British school buildings harbour potentially deadly asbestos, but experts warn it would cost too much to remove it all. Figures obtained from Freedom of Information requests to local authorities show 86 per cent of all schools in the country contain the killer dust, far higher than previous estimates. But Professor Julian Peto, one of the country's leading experts on asbestos, said removing it all was not an option as it would "only save" around 25 lives a year in 50 years' time when effects of asbestos on pupils will take hold. He said: "You cannot rebuild all the schools in Britain to prevent about 25 deaths a year. "These are deaths that will occur predominantly over the age of 70. "You have to remember that is the effect of childhood exposure." However Michael Lees, 67, founder of the campaigning group Asbestos In Schools, who obtained the figures, argued: "We expose a large number of children to asbestos in schools and this is contributing to the terrible death toll. "Successive governments brushed this under the carpet because the disease can take decades to develop." Mr Lees, a father of two, from Hardsworthy, north Devon, lost his wife Gina, a primary school teacher, in 2000 when she died aged 51 from mesothelioma. Last week a review ordered compulsory asbestos training for teachers.

James Hardie asbestos victims to get extra \$106m in support from NSW - The government will

remove the re-insurance recoveries loan cap for the James Hardie victims compensation fund, so it can borrow up to \$320m. The NSW government will provide an extra \$106m in support for James Hardie asbestos victims. The government will remove the re-insurance recoveries loan cap for the Asbestos Injuries Compensation Fund (AICF), which effectively means the fund can borrow up to \$320m to ensure victims can continue to be paid lump sums. The NSW treasurer, Andrew Constance, said the money would help provide certainty for asbestos victims and their families, whether they lived in NSW or any other state or territory. "While funding the compensation of asbestos victims is morally the responsibility of James Hardie, we are not willing to let a situation arise where those suffering do not get full and up-front payments," Constance said. The AICF had raised concerns it would have to pay asbestos victims in instalments because of a shortfall in the timing of funding from James Hardie. Constance said a 2010 facility agreement was supposed to allow the AICF to borrow \$320m from NSW – an amount intended to cover the unexpected downturn in payments from James Hardie as a result of the global financial crisis. But the loan cap restricts AICF borrowings to \$214m - the value of the outstanding insurance policy held by James Hardie. Just 45% of the payments from the AICF goes to NSW residents. The NSW premier, Mike Baird, has written to the prime minister, Tony Abbott, saying it is fair and reasonable to expect the Commonwealth, as well as other state and

territory governments, to bear their fair share of funding for victims outside NSW. The AICF was established as part of an agreement with James Hardie in 2005 to provide compensation for

As we reported in our last newsletter IN NOVEMBER 2014 the decision in June 2014 of the Supreme Court of Victoria in Multari V Seltsam Pty Ltd had a significant impact on the Victorian asbestos compensation jurisdiction, causing uncertainty for some asbestos disease sufferers seeking compensation.

As a result of this decision, Part VBA of the Wrongs Act (Vic) 1958 has been found to apply to sufferers of asbestos related diseases, where they have been exposed to asbestos outside of employment governed by Victorian workers' compensation schemes. For example, Part VBA will apply to claimants who were exposed to asbestos through home renovation work, or if they were exposed to asbestos dust washing the contaminated work clothes of their partners. Part VBA requires that these claimants obtain a 'significant injury' certificate in order to obtain damages for pain and suffering compensation. This process requires an assessment by a specially qualified AMA practitioner that the person has a 5% whole of body impairment.

The application of Part VBA to certain classes of asbestos disease sufferers creates an extra burden on vulnerable claimants already suffering under the weight of their diseases. It may also lengthen compensation claims by many months. There is no reason why claimants with terminal, insidious, asbestos related conditions should face unnecessary delay and red tape while attempting to receive fair compensation for themselves and their families.

Asbestos Council of Victoria/GARDS wrote letters to the Victorian Attorney General and our local State politicians to try and have this unjust and cruel red tape changed for asbestos sufferers before the State Government went into care taker mode before the up and coming elections on the 29th November. We were very pleased to advise our readers that the State Government did make changes to the Wrongs Act - this is the contents of a letter sent to us from the Justice Department prior to the last election. Win Win Win Win!!!!!

You will be PLEASED to hear that the Government has now made the Wrongs (Part VBA) (Asbestos Related Claims) Regulations 2014, which exempt sufferers of asbestos-related disease (defined as asbestosis, asbestos-induced carcinoma, asbestos-related pleural diseases, and mesothelioma) from the operation of Part VBA of the Act. The regulations commence on 30th October 2014 - IMPORTANT PIECE OF

NEWS it was also stated in a media release that the Government will examine whether legislation should be introduced into the next Parliament to apply the changes to any proceedings already issued that may have been affected by the Supreme Court's

decision this year. This last statement made in the media release was because we had asked for the regulations to operate retrospectively - meaning we wanted those who had already initiated cases would also be included in the legislation change - this was so those sufferers did not fall through the cracks. ACV/GARDS pursued this with vigour when the new government was installed after the elections last November 2014. We are pleased to inform you that we were successful in getting the claims already initiated and not finalised being included in the new law retrospectively - here are two Hansard Documents from Russell Northe - Member for Morwell and Harriet Shing - Upper House Member for Eastern Victoria where they talk about the win - we thank the new Labour Government for making the last part of the Wrongs Act 1958 "RIGHT FOR ASBESTOS

SUFFERERS AND THEIR

FAMILIES" ACV/GARDS are very proud to have played a part in this very important piece of legislation

Ms SHING (Eastern Victoria)—I rise for the first time to support a bill in this place, and it is with great pride and humility that I make my contribution to the Wrongs Amendment (Asbestos Related Claims) Bill 2014. In the first instance I join my colleagues from all sides of the chamber who have given their unequivocal

support to this bill and note from the outset that the work that has gone into its carriage and drafting and the consultation process which has preceded its introduction has been swift and effective and motivated by entirely the right reasons—namely, to give effect to alleviating impediments to access to justice for terminally ill Victorians who are suffering from asbestos-related diseases.

I have had the great pleasure and privilege of learning from the inspirational views and advocacy undertaken by people such as Vicki Hamilton, people who have spearheaded change and been enormously progressive in educating people from all over Victoria about the dangers associated with asbestos exposure, whether that be in the workplace, home or incidentally. Her work ought to be recognised as contributing to the consultation that went into this bill, which delivers on a very clear commitment by the Andrews Labor government to build further on the work commenced by the previous government to create prospective legislation, which we are now pleased to extend to become retrospective—for example, the significant injury process will extend back to cover claims filed after 30 October 2014 and the small number of claims that were still on foot and filed before that date which would not otherwise have extended the benefit of the changes to legislation and the

regulations effected under the previous government.

This bill covers all asbestos-related claims, including those that were filed before the making of the regulations. To that end the benefit and intent of the policy that underpins it is absolutely clear for all to see. In essence, the retrospective operation of this bill will give significant comfort to those who were directly affected by the 2014 decision in the Supreme Court in Multari v. Amaca, which held that claimants with asbestos-related conditions were not exempt from the requirement to demonstrate that they had suffered a

significant injury. In this instance the importance of making sure that significant injury is accepted as an outcome in incidents of mesothelioma, asbestosis, asbestos-induced carcinoma and asbestos-related pleural disease cannot be underestimated. The rest of Harriet speech can be read in the Victorian Hansard dated: Thursday 26th February 2015 - WRONGS **AMENDMENT (ASBESTOS**

RELATED CLAIMS) BILL 2014 Mr NORTHE (Morwell) — It is a great pleasure to rise this afternoon to speak briefly on the Wrongs Amendment (Asbestos Related Claims) Bill 2014. It is good that in this place there is bipartisan support on some pieces of legislation, and we make it very clear that the coalition is supportive of this legislation. Asbestos has been and unfortunately still is a scourge on many of our communities. My community of the Latrobe Valley has suffered much from having asbestos in the industrial areas of Morwell and surrounds, but to this day a large number of residential properties still have asbestos in them. It is something we certainly need to be very cognisant of and careful about. As the member for Niddrie and the member for Hawthorn articulated in their contributions, the consequence of being in contact with asbestos is that people can suffer from awful, insidious diseases that prolong suffering. Unfortunately, particularly in my region, we have seen many people fall victim to asbestos-related diseases. There is much work that needs to be done in that regard. This legislation is in response to a Supreme Court case that was heard in June last year. I commend the then Attorney-General, who is in the chamber at the moment, for his great work in making sure that this anomaly within the act was addressed, firstly, by way of regulation and now by way of legislation. I repeat that we as a coalition are pleased to support this. I do not want to speak for long, because what needs to be said has already been said, but I want to commend GARDS, which is Asbestos Council of Victoria Gippsland Asbestos Related Disease Support Inc. Anybody who knows of GARDS would know Vicki Hamilton

Parliament would well know of her and her team's advocacy over a long period of time. Unfortunately Vicki's family, like a lot of families in the Latrobe Valley, have had family members who have suffered from asbestos-related diseases. Her advocacy over a long period of time is well recognised. In fact she is now Vicki Hamilton, OAM, deservedly so, for her contribution to this particular space. I incorporate some comments from the GARDS newsletter of November 2014, just prior to the election. STATUTE LAW REPEALS BILL 2014 Thursday, 12 February **2015 ASSEMBLY 301** In part it talks about an update on Multari v. Seltsam Pty Ltd and the Wrongs Act 1958 under the heading 'Win! Win!'. It goes on to talk about the decisions made by the then Attorney-General, now the shadow Minister for Industrial Relations, who is at the table next to me, in introducing legislation to right the wrongs of what had occurred previously. In part it talks about the need for legislation to be considered in the future, which the new government has now introduced into the Parliament. I can certainly assure the house that while we continue to get strong advocacy from GARDS, the organisation is very pleased with the Attorney-General of the time and all members of Parliament for making sure that this anomaly was rectified. I put on the record that it has been bipartisan support. It is one of those issues where you can sit in a room with members of Parliament from all political persuasions and have a discussion about ways to find a good outcome. I conclude by quoting from that particular newsletter: Thank you to all concerned that made this happen — the Attorney-General Hon. Robert Clark and his department, Gary Blackwood, MP, member for Narracan, Minister Russell Northe, MP — I should include myself in that — Johan Scheffer, upper house member for Eastern Victoria — a Labor member — and those who helped with writing letters — the law firms who represent asbestos sufferers; unions — you all did a great job for a wonderful outcome for Victorian asbestos sufferers and their families. I think that says it all, and that is why we as a coalition support this legislation. This exert can be read in the Victoria
