Shestos Shippets

Inhaling chemotherapy drugs may reduce harmful effects for patients with Lung Cancer, Mesothelioma

Scientists in Scotland are developing a new treatment option that would allow patients to receive chemotherapy drugs in vaporized form.

Asbestos scandal in the region

Hundreds of unsuspecting ACT businesses could contact deadly asbestos because the buildings were "outside the scope" of a \$100 million clean-up funded by the Federal Government in the late 1980s.

NSW Police exposed to asbestos

The New South Wales Police Association says officers have been exposed to asbestos in homes and police stations for years because a report into the problem was buried.

Stop silent killer ruining more lives

An argument has erupted in South Australia between industry stakeholders and the State Government about whether legislation before Parliament for harmonisation of workplace health and safety laws around Australia will put a new wave of maintenance workers, builders and DIY-ers at increased risk of exposure to asbestos.

'Vital evidence' discounted in Hardie disclosure trial

The NSW Court of Appeal might have underplayed evidence "of the highest importance" when exonerating seven James Hardie directors last year over their disclosure about asbestos compensation, a High Court judge said.

Comfort and Support for Asbestos Victims in Tasmania

The Tasmanian Minister for Workplace Relations, David O'Byrne, officially launched Tasmania's first asbestos compensation scheme on 26 October 2011.

Asbestos victim to fight any appeal

A James Hardie asbestos victim awarded \$2 million on Wednesday 26 October 2011 may seek further damages if the company appeals against the compensation decision.

New hope for cancer patients

There is new hope for Queensland sufferers of Mesothelioma with the introduction of cutting edge technology at the Royal Brisbane and Women's Hospital.

Therapy hope for asbestos disease

The Associate Professor at the University of Western Australia is researching a way to boost an individual's immune system to tackle the fatal asbestos disease, Mesothelioma.

Trail of deceit as emails expose asbestos scandal

An internal email chain has exposed key police personnel who deliberately kept thousands of officers and their families in the dark about asbestos and other poisonous hazards in stations and houses across NSW.

Canada under fire over asbestos exports

A Canadian health expert has described his government as a "purveyor of death" for continuing to export asbestos to India, ABC's Foreign Correspondent has reported.

Reality renovators exposed to deadly disease

Reality TV shows such as The Block and The Renovators are putting DIY home renovators at risk because they don't warn about asbestos dangers, a federal politician says.

Move to ease rules for asbestos victims' families welcomed

The families of dust disease victims would be able to start legal proceedings after the victim died, under a recommendation of the Law Reform Commission the Attorney-General is considering adopting.

Workers' families call for government to stop supporting asbestos industry

Families of Ontario workers who died of asbestosrelated diseases are making a last-ditch plea to stop a project that would revive one of Canada's only remaining asbestos mines.

James Hardie Builds on stability

Building products maker James Hardie has returned to profitability and a few weeks ago confirmed its full-year earnings guidance.

Electronic "Nose" appears to detect Mesothelioma

Research scientists from Italy and The Netherlands report they have developed a device they've called an "electronic nose", which can tell if an individual has malignant pleural mesothelioma by simply sampling their breath.

Mesothelioma prognosis accuracy improves with PET/CT

More research has confirmed the value of FDG-PET/ CT technology for predicting treatment response in mesothelioma, especially when the scan is conducted in two phases.

Upper house passes motion urging government to get Canada to stop producing and exporting the harmful mineral

The Australian Senate passed a motion condemning Canada for the country's continuing exporting of asbestos to developing countries in Asia.

Climate change adds urgency to asbestos removal

Australia may no longer be able to consider 'bonded asbestos' safe due to the increase in natural disasters causing asbestos fibres to be released, a scientific conference of cancer experts in Perth was told.

Company appealing asbestos payout

A mesothelioma sufferer awarded more than \$2 million compensation after contracting the disease from playing in asbestos waste as a child is "very disappointed" the company deemed responsible has decided to appeal the ruling.

Asbestos victims deserve better: NSW Labor

Compensation should be given to asbestos victims' families if they die before their case is finalised, NSW shadow Attorney General Paul Lynch has said.

Italy asbestos trial verdict expected in February 2012

A massive class action lawsuit in Italy against a Swiss billionaire and a Belgian baron over 3,000 allegedly asbestos-related illnesses and deaths ended this week and a verdict is expected in February.

Blood platelets have key role in signalling malignant cancer cells to spread

Researchers have been trying to gain a better understanding of the processes that permit cancer cells to break away from the original tumours and spread. New research sheds light on the active role played by blood platelets.

Radiotherapy and EPP is a winning combo for some mesothelioma patients

Another study has confirmed the value of radiotherapy as an adjuvant treatment for mesothelioma patients who undergo extra pleural pneumonectomies.

Mesothelioma, Erionite warning issued by NIOSH

The National Institute of Occupational Safety and Health (NIOSH) called for more protective measures on job sites for workers who may be exposed to Erionite, a mineral similar to asbestos. NIOSH warned that Erionite is America's next mineral danger.

India deal won't study asbestos: Analysts

Canadian exports of asbestos to India won't be examined as part of an environmental assessment recently launched in connection with the Canada-India free trade talks, say experts – and that has some calling on the government to widen its scope.

Canada's asbestos industry suspends work for first time in 130 years

Canada's once-mighty asbestos sector has ground to a halt for the first time in 130 years, as production of the controversial fibre has stalled in both of the country's mines.

Thalidomide ineffective in Mesothelioma patients

A research study in the Netherlands has found that the drug Thalidomide does not slow the progression of malignant pleural mesothelioma nor does it improve the survival rate of those suffering from the disease.

No Govt asbestos fees in South East

The Member for Bega, Andrew Constance, says there are no Government charges being applied in NSW south east for the disposal of asbestos.

Aussie acting veteran Harold Hopkins dies

Australian actor Harold Hopkins has died in a Sydney hospital from the asbestos-related cancer **mesothelioma**. Hopkins, who had major roles in several classic Australian movies including Gallipoli, Don's Party and The Club, died at Neringah Private Hospital

Rudd to move proposal on banning asbestos

Foreign Minister Kevin Rudd wants the Labor government to lead the world in securing a global treaty to ban asbestos use and trade.

White asbestos found on beaches sparks warning

The Northern Territory Environment Department has erected warning signs after the discovery of pieces of white asbestos on some of Darwin's northern beaches.

Legislation due on asbestos-related pleural plaques

People suffering from the asbestos-related lung condition pleural plaques will be able to seek compensation from next week due to new legislation in the United Kingdom.

This includes home visits by GARDS volunteers, a telephone information/support service 24 hours, 7 days a week. GARDS has an office, which is open for sufferers, their families, carers and the general community to access at the times listed in the information section.

GARDS INC. Support also conducts a monthly meeting (1.30pm - 3.30pm) on the last Tuesday of the month) where guest presenters are invited to provide information about support services of all kinds and any other topics of interest that the members might find of relevance. The meetings also provide a gathering place for experiences; GARDS Support is open to anyone whose lives have been affected by asbestos, their families and the general public.

GARDS loans out free of charge to asbestos sufferers - oxygen bottle regulators, conserving devices, oxygen home concentrators, wheel chairs, oxygen bottle carriers, nebuliser, walking frames & walking sticks.

We also have an extensive library of books, DVDs and CDs on asbestos issues, health, social and environmental that we loan free of charge to those wishing to improve their knowledge.

GARDS can provide professional counselling with a qualified psychologist free of charge for those who have been diagnosed with asbestos related disease and also their family members. If preferred telephone counselling can be arranged.

GARDS Inc. Evening Meetings

GARDS has an organisational, activities and advocating arm. Interested financial members can come along to evening meetings, which are, conducted 7.30pm - 9.30pm on the third Tuesday of the month.

These meetings provide a focal point for information

sharing and problem identification. The aim of this group is to focus on improving health and support services and any other issues deemed relevant to improving overall outcomes to asbestos sufferers, their families and the general public. Thus ensuring asbestos-related issues are kept in the public eye and trying to rid our environment of asbestos products.
