ASBESTOS AWARENESS DAY 2004

On the 30th of November in the Rose Garden, Morwell GARDS held its annual Asbestos Awareness Day. There were a number of speakers who were asked to speak on asbestos issues, some of those were: Peter McGauran MP Member for Gippsland, Brendan Jenkins MP Member for Morwell, Darrell White Latrobe City Mayor, John Parker Gippsland Trades & Labour Council, Bette Phillips Creative Ministries Network and Angela Jones daughter of a woman who passed away with mesothelioma. Around two hundred turned out on this hot and sunny day and all those who attended thought that the day had been a memorable one and had been a significant step forward in the recognition of asbestos issues in Latrobe Valley. We thank all those people who attended and we thank you for your support to asbestos sufferers everywhere.

JAMES HARDIE UPDATE

October 28th 2004 saw the GARDS members back on the road again (thank you CFMEU for the bus) protesting at the Telstra AGM where Donald McGauchie Chairperson of Telstra was conducting their AGM. Mr McGauchie is also a board member of James Hardie (conflict of interests) many good workers at Telstra had lost their lives to asbestos produced by James Hardie. Mr McGauchie was being asked to resign. The protest drew a lot of attention and our members who participated felt that it had been worthwhile. Then on December 21st 2004 GARDS received news that a Heads of Agreement had been reached and signed that day by the ACTU, NSW unions, Bernie Banton representative of the asbestos victims. This document is not a legally binding document but is a significant step forward towards making sure that the James Hardie company funds current and future compensation liabilities to Australian victims of its asbestos products. A legally binding 'Principal Agreement' will conclude the negotiations by June 2005. The 'Heads of Agreement' provides for:

An open ended funding commitment – ie. No cap on the overall funding,

No cap on payments to victims,

The creation of a Special Purpose Fund, which may be the MRCF, which will receive funding from James Hardie and make payments to claimants,

The payment of an up-front cash 'buffer' equivalent to two years of claims plus the payment of a further year of claims in advance – this buffer will be approximately \$250 million,

Additional annual payments form James Hardie based on an annual actuarial assessment of the liability for asbestos claims

A maximum amount, or cap, on the annual James Hardie payment will be set at 35% of the company's free cash flow. In the first year of the agreement this cap is equivalent to over \$70 million

A minimum term in the funding arrangement of 40 years. The term of the agreement will be extended indefinitely if this required,

Funding from James Hardie for asbestos education and medical research

The 'Heads of Agreement' also deals with other important steps details such as how funding for asbestos compensation will be secured, how the arrangements entered into will be made legally binding on the company and how the company can ensure, that it can put this all behind it and get on with business. The Principal Agreement will need to be voted on in June 2005 and accepted by James Hardie shareholders.

This will be the largest personal injury settlement in Australia's history. A great achievement for everyone involved. Well done to all those who have participated in some way!

WORKERS DONATE TO GARDS

GARDS was very pleased to accept a generous donation of \$460 from management of Hooker Cockram and construction workers at the Police Court Complex & Cancer Care Centre sites.
