### BARYULGIL INDIGENOUS COMMUNITY

GARDS Secretary Vicki Hamilton accompanied Dr Jock McCulloch from RMIT well known author on social justice & asbestos issues and Dr Tony LaMontagne Associate Professor with the centre for Health & Society, School of Population Health, Melbourne University on a trip to Sydney in late September to visit some of the last remaining families of mine workers from the Baryulgil James Hardie Asbestos Mine.

The plight of the asbestos mine workers, near Grafton was first broadcast on the ABC program called Broadband 30<sup>th</sup> of September 1977 by Matt Peacock who won second prize in the Sir William McKell award for environmental journalism. The programs were apart of an overall series on occupational health called "Work As A Health Hazard" designed to increase public awareness of the dangers, which are ever present at the workplace.

The mine first opened in 1944 and had mostly a predominantly indigenous work force but ironically, the very mine which had enable the people of Baryulgil to have financial stability and security was quietly but surely killing them. Their story is the same story of many communities where asbestos was mined or used.

The Baryulgil story talks about residents using waste from the local mine to fill in holes in their driveways. When the Health Commission team arrived at Baryulgil they found to their shock that the local shire council had used the waste to repair washaways on most of the nearby roads. It had been common practice for the council to dump truckloads of asbestos on the roads and driveways around the mine. In one twenty-mile drive they counted fourteen patches of tailings some up to a foot deep and one was at a local picnic spot. There were vast quantities of asbestos dust found in the settlement, significant readings were taken from the gutters, and on the leaves of nearby trees – indicating that a lot of dust was airborne in the area.

The mine workers children played in the mine tailings for years & a large pile of tailings once stood next to the newly completed school building, the dust use to blow across the playground in the wind. The mine closed in 1979 a couple of years after the report went to air. Members of the Baryulgil community have been fighting for more than 20 years, seeking action and justice for their families and their community who they believe have suffered as a consequence of contact with the James Hardie Baryulgil asbestos mine.

There have been <u>two</u> major investigations, the reports of these inquiries were published in 1984 (the House of Representatives Standing Committee on Aboriginal Affairs inquiry) and another one in 1990 (the Race Discrimination Commissioner of the Human Rights and Equal Opportunities Commission inquiry) they have also been the subject of intense investigation by the NSW Health Commission. Following one of the reports made some of the recommendations were implemented, but not without delays. For example the funding to establish the Bulgarr Ngaru Aboriginal Medical Service in Grafton was eventually provided. But there are many other recommendations that have not been implemented fully or not at all. In all there have been multiple recommendations about how the legal, medical, public health, environmental and other issues raised by the experiences of the community past and present residents could be addressed. Both in the past and recently, responses by government and others to issues relating to Baryulgil have been appalling.

After speaking with the people of Baryulgil it begs understanding why there has really been nothing done for this community. Is this situation just all too hard for governments to tackle? Again we see James Hardie at the front of another scandal that has been taking place for over 20 years. James Hardie has managed to successfully avoid addressing their moral and legal obligation to this community as they are now attempting to do with the rest of Australia. Its time for the Australian Government to stand up and be counted for the people of not only Baryulgil but all Australian communities who have been affected by asbestos.

Both Federal and State Governments should be making a concerted effort to make corporations accountable for their actions. The decisions these companies make in the name of profits kill workers and their families and they should not be able to avoid their legal & moral responsibilities. GARDS calls on **anyone** who could possibly assist the people of Baryulgil in seeking justice for their suffering. To Lily, her family and friends I thank you so much for making Jock, Tony and myself feel very welcome and sharing your personal stories with us. We will keep in touch and we will do whatever we can to help.

It is also hoped that some power industry management that have been invited, will be able to find sometime in their busy schedules to be able to show support by speaking at the event. John Parker Secretary of the Gippsland Trades & Labour Council will also be speaking.

The theme this year is a "whole of community response". <u>Asbestos Awareness badges</u> with a feather symbol on the front are being sold on the day and prior to day for \$2.00. If anyone would like to purchase one before the day please contact the GARDS office. The badge highlights Asbestos Awareness week and the card the badge is attached to advises of common places asbestos may be found.
