



Hobart neighbourhood anger as demolition developer helps with asbestos clean-up - Rhiannon Shine - 2 Mar 2017 – ABC News

Neighbours to a partially demolished Hobart property are outraged the owner has returned to the site to assist with asbestos removal, despite facing hefty penalties over the demolition. Key points: Heritage-listed 1890s house purchased at auction for \$445,000 - On Sunday it was demolished without council permits - A "stop work" notice requires all asbestos to be removed within three days -The heritage-listed house was demolished without a permit on Sunday after locals and a council representative tried to intervene. On Monday, council confirmed asbestos was present at the site. The owner is facing a possible 10-year ban on any development on the property and has been served with a notice to Immediately stop work -Engage a licensed asbestos removalist - Erect signage restricting access to the site - Prevent material or debris escaping "on to or into" the road or neighbouring properties - Remove all asbestos within three days - Provide certification that all asbestos has been removed from the property and the property "is safe"

ACT workers compensation changes for asbestos impacted workers criticised – *Kimberley Le Lievre* – 26 March 2017 – Canberra Times

Changes to workers compensation laws for asbestos victims in the ACT could leave terminally ill people short changed, a legal expert said. While the government admitted the new lump sum payment option was "relatively low" compared to other jurisdictions, the idea was to offer asbestos victims a simple and immediate alternative to court proceedings. The changes come into effect in the territory on July 1. Victims will be able to claim the maximum lump sum payout of \$140,000 from the default insurance fund, which is made up of levies paid by insurers.

Captain Cook Memorial Jet longevity a testament to original engineer – 25 March 2017 – Kimberley Le Lievre – Capherra Times

Lake Burley Griffin's fountain is a sight to behold for most Canberrans but for John Randall the view is even more significant - it's a memory of his late father who built it.

The fountain on the lake has come back to life after a major refurbishment caused an intermission in its iconic 47-year career. It was the first time in almost half a century the landmark needed a complete restoration, a tribute to the handiwork of lead engineer on the project, the late Ken Randall. John Randall was 13 years old when he watched on proudly as his father met the Queen at the inauguration of the monument in April 1970. Ken passed away from mesothelioma in 2003 but his legacy lives on.

He was the lead engineer during the construction of the fountain, one of a variety of Canberra landmarks he was involved with during his time in the national capital.

Asbestos assessor recommends demolition of two buildings at Ainslie shops — Kirsten Lawson — 25 March 2017 — The Canberra Times

The asbestos assessor investigating contamination at the Ainslie shops has recommended the long-term demolition two of the heritage buildings at the popular shopping centre - the corner building housing Edgar's Inn and the one next door. Robsons has also pointed to the poor condition of the eaves and the deteriorating roofs on the buildings, saying high winds, severe thunderstorms or a fire could result in asbestos contamination of the street, footpath and park. At 3 and 5 Edgar Street, tarpaulins over the roofs created a risk even in a less-severe weather event that damaged the roof, and water damaged ceilings could allow contamination of the buildings below. The dangerous "Mr Fluffy" loose-fill asbestos was installed in the second-level ceiling of the corner building, above Edgar's Inn almost 50 years ago. Investigations in February and March show it has now migrated into the ceiling of the neighbouring building, which houses a newsagency and laundromat on the ground floor and a therapeutic massage business on the first floor.

Health concerns in the Latrobe Valley - Friday 24 March 2017 - RN Breakfast - Fran Kelly

The Hazelwood power station has been central to the Latrobe Valley's economic and social identity for decades. It's also left its imprint on the region's health. The Latrobe Valley has one of the highest rates of lung cancer and cardiovascular disease in Victoria, not to mention a long history of asbestos-related disease. Studies are only now starting to determine whether there any links between these health statistics and the presence of the coal mine and power station. There's also concern about the long-term consequences of a mine which blanketed Morwell in smoke for more than a month back in 2014

Vic company sued over asbestos death - *Jacqueline Le - Australian Associated Press – News.com - 27 Feb 2017*

The family of a Melbourne man who died from mesothelioma is suing the operators of the former Wunderlich cement factory where his father used to work. Samual Azzopardi was 69 when he died in February 2016 after developing the disease allegedly caused by his exposure to asbestos as a child. His father is said to have come home covered in dust and fibres from his job at Wunderlich. Mr Azzopardi was allegedly exposed to asbestos a second time when he used concrete sheets purchased from Wunderlich to renovate his parents' bungalow, Michael Wilson QC told a Victorian Supreme Court on Monday. "There is no issue in this case that what caused his death is mesothelioma," Mr Wilson said in his opening statement before a jury of six. Mr Wilson said between the 1950s and 1970s, Mr Azzopardi's father, Charlie, would come home covered in dust and fibres from his job at Wunderlich, which involved cutting open bags of raw fibres. "Charlie was working in a dusty environment," he said. "He would bring home the fibres on his work clothes ... and he would come into the family home and contaminate the furnishings in the house."Sam was a young boy at this stage."

New Director Adds Expertise to Asbestos Research Institute

Dr. Ken Takahashi joined the Asbestos Diseases Research Institute (ADRI) in Sydney, Australia, with some very lofty goals. The institute's new director wants to make the world a safer place. "My goal is to help establish this institute as a global centre of excellence for asbestos-related disease," Takahashi told Asbestos.com. "The mandate here is to serve the Australian people, which I take to heart. But serving the Australian people, and serving the world, are not mutually exclusive. You can do both. And we will try." Takahashi, 60, left a long time position as a professor and director at the University of Occupational and Environmental Health Japan to join ADRI, the world's only research institute focused exclusively on asbestos and asbestosrelated diseases. Exposure to asbestos can lead to a number of serious health issues, including pleural plaques, asbestosis, lung cancer and mesothelioma. He brings his expertise as a renowned epidemiologist to complement an already highly regarded

A construction company, J Hutchinson Pty Ltd., has developed a free interactive asbestos guide to help homeowners and small businesses working with, or removing asbestos-containing products from residential areas. The guide, Working Safely with Asbestos shows what asbestos is and what type of buildings are likely to have asbestos containing materials by the build or renovation date; the types of medical conditions related to asbestos exposure; common locations where asbestos-containing materials may be found in a residential building; how to prepare the work site and utilise safe work practices when handling asbestos in a domestic environment; the right tools, materials and personal protective equipment (PPE) to use when working with asbestos-containing materials; and how to clean up and dispose of asbestos-containing materials; and how to clean up and dispose of asbestos-containing material waste and PPE. The use of asbestos has caused a global stir when health organisations around the world warned of its serious health implications. Australia has banned asbestos since the 1980s, but hundreds of Australians continue to be diagnosed with mesothelioma, asbestosis, lung cancer and other asbestosrelated diseases every year. NT: Safety Culture – Asbestos control set to become responsibility of Northern Territory government –

Asbestos control will now become the responsibility of the Northern Territory Government following a motion to include the issue in the Public and Environmental Health Act passed the 2017 NT ALP conference. NT Health Minister Natasha Fyles said the government acknowledged the Territory communities and workers were "rightfully concerned about asbestos issues". "The Northern Territory Government takes the asbestos issues seriously and will consider all of the concerns raised at this weekend's Labor conference," she said. "NT WorkSafe isn't involved in the physical clean-up of asbestos, but they are charged with ensuring high standards are maintained and ensuring businesses, workplaces and other organisations comply with their obligations under the law." CFMEU organizer Roley Cummins following the motion's success wants to sit down and come up with the plan along with representatives from the NT Labor Government

Asbestos at Wamberal Beach remains in place nine months after being exposed - April 6, 2017 – Community Coast News Source: Apr 3, 2017 Pat Aiken, Coastal Residents Incorporated - Jackie Pearson, journalist

Mr Pat Aiken, who has recently announced he will be standing for election to the new Central Coast Council in September, has raised the alarm about what he believes to be thick asbestos roof sheeting exposed by storm damage at Wamberal Beach. According to Mr Aiken, who made a notification to the EPA about the exposed sheeting on Friday, March 31, it has been exposed, subject to the weather and accessible by the public since June 2016. In a written statement, the EPA said that it had responded to reports of bonded asbestos being discovered on Wamberal Beach after being notified by a resident through Environment Line on March 31. "Central Coast Council is the

appropriate regulatory authority for this matter, and the EPA understands that they are treating this situation as a priority," the EPA statement said. "The EPA is working with council and will provide assistance as required."

Central Coast Council said it had received reports of exposed asbestos on Wamberal Beach following the June 2016 storms.

Port Stephens Mayor Bruce McKenzie's family company has pleaded not guilty to waste dumping - NSW: Newcastle Herald – Joanne McCarthy 8 Apr 2017

PORT Stephens Mayor Bruce MacKenzie's family company has pleaded not guilty to using Macka's Sand and Soil at Salt Ash as an unlawful waste dump. The plea was entered on Friday in the Land and Environment Court after the NSW Environment Protection Authority finalised its case against the company, Grafil Pty Ltd, and directors Mr MacKenzie and son Robert. The charge, under the Protection of the Environment Operations Act, carries a \$1 million maximum penalty with a further penalty of \$120,000 for each day the offence continues. The father and son also face possible special executive liability as directors of Grafil Pty Ltd, trading as Macka's. The NSW Environment Protection Authority launched criminal proceedings against Grafil in the Land and Environment Court in May last year after investigations of alleged dumping from 2013, when stockpiles of waste up to eight metres high, 40 metres wide and 100 metres long were found near and in waterways.

Date set for Hurlstone Park Bowling Club to be demolished - Danielle Buckley - Canterbury-Bankstown Express - April 9, 2017

THE historic Hurlstone Park Bowling Club will be demolished — after asbestos and structural issues were found in the decaying building. The clubhouse, built in 1944, sits on Crown land but the club is responsible for its upkeep. An assessment of the site was prompted in 2015, after the former Canterbury Council rejected a five-year extension of the club's lease, and put the club on the open market. The assessment revealed \$200,000 worth of structural defects including loose bricks, insufficient structural support on the dance floor and friable asbestos in several parts of the building. The building was also deemed not fire safe and has no disability access.

Flood safety tips: cleaning up dust, asbestos and mould - April 10, 2017 - Aslan Shand – Echo Net Daily

Cyclone Debbie has caused major damage throughout the north coast region and as people continue to clean up their homes and businesses the Northern NSW Local Health District is reminding people to take precautions against mould, dust and asbestos. Dust and mould Irritated eyes, running and blocked nose, sneezing and wheezing can be caused by mould and dust leading to allergic reactions and other breathing problems. Using a P2 mask available at hardware stores when cleaning or in dusty conditions is recommended

Going back home - Returning to you home and businesses after a flood the following steps are recommended: Clean up and dry out the building quickly. Open doors and windows and use fans or dehumidifiers to dry out the building. Remove all porous items that have been wet for longer than 48 hours and that cannot be thoroughly cleaned and dried. These items can remain a source of mould growth and should be removed from the home or building. Porous, non-cleanable items include carpeting and carpet padding, upholstery, wallpaper, drywall, ceiling tiles, insulation material, some clothing, leather, paper, some wood and wood products, and food. Removal and cleaning are important because even dead mould can cause allergic reactions. Clean wet items and surfaces with detergent and water to prevent mould growth. Temporarily store damaged or discarded items outside the home or building until insurance claims can be processed. Removing mould - Routinely cleaning surfaces using mild detergent or vinegar diluted in water (4 parts vinegar to 1

To make up a 10 litre bucket of disinfectant, fill the bucket with water and then add one of the following 50mls (quarter of a cup) of 4 per cent chlorine (household bleach) OR 8-16mls (desert spoon) of 12.5 per cent chlorine (liquid pool chlorine). Tea Tree oil is also effective use a 3 per cent solution or (2 teaspoons in a spray bottle with 2 cups of water)

It is recommended PVC or nitrate rubber gloves, safety goggles, masks and safety shoes be used in a well ventilated room when

bleach is used. Always allow cleaning solution to remain on surface being treated for at least 20 minutes before rinsing off. Ensure the surface is dried completely once cleaned. Absorbent material, such as carpet, may need to be professionally cleaned or replaced. Asbestos - Asbestos is a concern because when it is broken up it may create airborne asbestos dust particles. Many properties built or renovated before 1987 are likely to contain asbestos, usually in the form of roof and wall sheeting. Generally, the asbestos will remain trapped in the cement matrix (bonded asbestos) and cause no harm. When it is broken up or worked on with power tools such as drills, grinders, saws etc. - small fibres of asbestos will be released into the air. It is the airborne fibres that can cause illness when inhaled.

Two business owners fined over the illegal dumping of asbestos in public bushland in Victoria may have been doing it for years, the state's environment protection authority says.

WorkSafe spokeswoman Caitlin Rode said it ordered all activity on the site to stop following "a recent complaint that this work may have breached OHS regulations". EPA southern metro manager Marleen Mathias said stockpiles of contaminated soil remained on site and unexcavated land was likely to be contaminated too. Asbestos discovered in Edge Hill rubble - Dominic Geiger - The Cairns Post - April 13, 2017

ASBESTOS has been discovered in the rubble of a much loved Queenslander recently demolished without Cairns Regional Council's permission.

The unauthorised destruction of 23 Fleming St, Edge Hill, on Tuesday morning shocked neighbours, many who lobbied hard for its ¬preservation.

Following the outcry, both Cairns Regional Council and Workplace Health and Safety Queensland launched investigations. Yesterday, a WHSQ spokesman confirmed "asbestos containing material" had been found at the site following a visit by an inspector. The house was owned by Bill Burdett, who yesterday denied it contained any asbestos. There was an asbestos warning sign attached to the outside of the building prior to its demolition, but Mr Burdett said he had placed it there to "keep people out". The Queenslander, which was located in a "character area" was the subject of a long running stoush between the council, Edge Hill residents and Mr Burdett. Eight weeks ago, Mr Burdett received council approval to move the house to 1 Fleming St, but that move never eventuated. Neighbour Lawrence Woodward, who has lost friends to mesothelioma, said he was now worried about his and others' safety.

Corporate spy infiltrated anti-asbestos campaign, court told – *The Guardian 9th Dec 2016 - Ian Cobain*

A leading corporate intelligence firm infiltrated the worldwide campaign to ban asbestos in a sophisticated and long-running espionage campaign, the high court in London has heard. Over a period of four years, the court was told, a spy working for K2 Intelligence Ltd masqueraded as a sympathetic documentary maker in order to gather a mass of sensitive material about the leading figures in the campaign, their methods, funding and future plans. K2 was in turn passing the information to its client, an as yet unnamed corporation based outside the UK that has interests in the asbestos industry. On Monday the court ordered K2 to identify its client, although the name of the spy – who was paid in excess of £460,000 in salary and expenses – remains a secret. In a witness statement to the court, the spy – currently anonymised as DNT, by order of the high court – said K2 had paid him £336,015 and he had received £130,430 in expenses.

Man killed by asbestos related disease – 27 Feb 2017 – Suffolk Free Press.co.uk

A Hadleigh man, who died from an asbestos-related disease, was first exposed to the material after being called up for National Service, an inquest heard. John Gant, 82, died at his home in Woodthorpe Close on September 26. On February 13, an inquest in Ipswich heard that, after working in the building trade, Mr Gant had, as a young man, been called up for National Service. It was while working as a motor vehicle mechanic that he was first exposed to asbestos dust from components containing the material. Assistant Suffolk coroner Kevin McCarthy said that, after ending his military service, Mr Gant had continued to work as a mechanic. Doctors confirmed last year that Mr Gant was suffering from the fatal condition mesothelioma, which is linked to asbestos exposure. Mr McCarthy recorded a conclusion that Mr Gant died as a result of an industrial disease.

Poorly Managed Asbestos Raises Mesothelioma Risk in English Schools – Surviving Mesothelioma - March 5, 2017 – mesothelioma lawyer info.com

A brand new authorities report has some sobering information for academics and college students in England: Nearly 20 % of faculties could also be failing to adequately shield them from asbestos, the first reason for malignant pleural mesothelioma. It provides a disturbing view of mesothelioma risk amongst England's academics and college students as a result of poor administration of the lethal toxin. Although a few of these buildings have been changed, many

others are nonetheless standing. According to the EFA report, four,646 of the faculties that participated in the survey stated that asbestos was current in their constructing.

Trump Will Likely Support Asbestos FACT Act - *Mar* 07, 2017 - *Beth Swantek* – *Asbestos.com*

A House Judiciary Committee approved the Fairness in Class Action Litigation and Furthering Asbestos Claim Transparency Act of 2017, one of numerous iterations of the legislation since 2004, which asbestos foes claim will hurt those seeking muchdeserved compensation. Repeatedly stalled in the legislature in previous years with a promised veto from President Barack Obama, supporters are hopeful President Donald Trump will support the bill as part of a reform package. Republican sponsor U.S. Rep. Blake Farenthold of Texas introduced the bill in February. Opponents Fear Asbestos Victims' Privacy Is at Stake Linda Reinstein, president of the Asbestos Disease Awareness Organization, vehemently opposes the bill and its previous version known as the FACT Act. "The FACT Act is designed to make it even more difficult for asbestos victims, including our ADAO community, to receive our 'day in court' and the compensation we deserve," Reinstein wrote on the organization's website. At issue is claimants' privacy. Under the bill, the asbestos trusts would disclose the claimants' private information in order for them to receive compensation. Formerly confidential data, such as their name, Social Security number, exposure history, as well as reason for compensation, would become public information.
