



many areas to explore around the



Profile on Jodie Deakes CEO of the Asbestos & Silica Safety and Eradication Agency


Jodie Deakes is the Chief Executive Officer of the Asbestos and Silica Safety and Eradication Agency (ASSEA). Jodie has over 24 years' experience working across all regulatory functions of the Queensland and New South Wales Work Health and Safety (WHS) regulators and has contributed at the national level representing both QLD and NSW WHS regulators at Safe Work Australia meetings and other national committees. Previously, Jodie was the Executive Director, Work Health & Safety Engagement and Policy Services at the Office of Industrial Relations Queensland from 2020 to 2023 and held senior executive leadership roles across SafeWork NSW.

As the Chair of the QLD Interagency Asbestos Group, a previous member on the Asbestos Safety and Eradication Council, and leading in support for impacted families, Jodie is passionate about preventing asbestos-related diseases.

Jodie is an alumna of the Executive Fellows Program of the Australia and New Zealand School of Government, is a graduate of the Australian Institute of Company Directors, and has a Bachelor of Business Management from the University of Newcastle.

At a personal level Jodie talks of her experience in all health and safety roles, of working with families with lived experience who, following the worst days of their lives, fight for change to save others.

Jodie's passion is driven by her family experience and close friends' own fight with cancer related diseases, and the dedication to service and community



Jodie led the code of practice related to horse safety for inexperienced riders which was the first non-national harmonised code of practice

following the death of a young girl learning to be a jillaroo.

She also

led the

development of the Speak Up app following the tragic death of a young man on a building site in Sydney. The development of this app not only allows vulnerable groups to communicate unsafe activities to the regulator but allows them to do so in a way that makes them feel safe. Jodie admits that she is always up for a chat with those who have ideas but don't know what to do with them, whilst also being honest when she thinks it may not be possible at that time. However, upon reflection Jodie laughs when she remembers something someone said to her years before and realises the time has come to do more with the

Jodie is unapologetic about her passion for a great culture and supporting leaders and the people she leads in the public service to be the best they can, in good times and bad. She says nothing is better when someone she has supported moves on to bigger and better things and continues to serve the community.

Reaching those who are most vulnerable and at risk, as well as those responsible for looking after them is a constant focus for Jodie. Growing up in a small regional town, with blue collar working parents, married to a tradie and having two gorgeous kids (her words) Jodie knows you can't expect to use a standard formula of education, awareness and collaboration across the community to get people to take notice and change behaviours. Jodie acknowledges that what works for one will work not for other and may not get the break-through needed. The process of how you engage is fundamental to ensuring the outcome you know you need to achieve.

Being well informed through targeted

research that is communicated in the right way and with connected data allows you to gain the credibility, trust and the impact needed. Jodie believes it's not enough to house all this great information and insight within the walls of government when others can benefit and use it in responsible and impactful ways across the community, both in national and international settings.

That's why Jodie is excited about her role as the CEO of ASSEA, allowing her to continue to engage with and learn from those with lived experience and others across the community on how to reach those she needs to.

Leading the design of two new important national plans for asbestos and silica, Jodie and her team have their work cut out for them. You can see the respect she already has for the ASSEA history, capabilities, and success, and she openly recognises that the new National Strategic Plans will step up the challenge for ASSEA, all the jurisdictions and the partners in and outside government.

Jodie says that when looking back over previous plans, so much has been achieved by the Agency, support groups and partners, and the ambition is really stepping up in the next plans. Commitment is not really a choice anymore if we are going to stop exposure and prevent the horrendous impacts of asbestos and silica related diseases. With the commitment and support of others, Jodie is confident that she and ASSEA will lead the task of coordinating the national effort over the next 6 years and identify and address other challenges as they arise.

Profile on Kim Brislane CEO Asbestos Dust Diseases Research Institute

I am a CEO, a Board Director, Company Secretary, Volunteer and an Activist. My specialisation is not-for profit leadership, and this has been honed through executive and strategic roles spanning 30 years. It was a collection of all this experience that led me to become the CEO of the Asbestos and Dust Diseases Research Institute, a job I absolutely love.

While I am all the things mentioned, I am not a Doctor, Researcher, Scientist or Nurse so my learning curve has been steep, challenging and intense. And while you won't see me in a lab coat anytime soon, after nearly three years at the helm I have developed a deep understanding of the very complex, political world of occupational disease and its dreadful impact on people and I am committed to steering ADDRI to eradicate asbestos and dust related disease head on.

My job is to grow, connect, protect, strengthen, advance and innovate the Institute. I see myself as its chief storyteller and its loudest cheerleader. Our work, as the name suggests is research into asbestos and dust diseases. We are designated by the World Health Organisation as its Collaborating Centre for the Elimination of Asbestos Related Diseases — and this is a world first. We are also the training partner for the United Nations and are currently executing projects across southeast Asia and Columbia.

Our team is small and dedicated and our scope is global; and with the continuing burden of asbestos and increase in silicosis our work is crucial.

Over the past three years we have seen a lot of change at ADDRI, and I am incredibly proud of each milestone. We have nearly tripled our team. We have established innovative partnerships that have ensured our viability and sustainability and we have secured significant grants to put concepts into action. We have strengthened and amplified our voice to speak louder for those impacted by asbestos and dust related diseases and also advocate for our entire national network.

Life as a CEO began in an unusual way and well before I joined ADDRI. I received a call to organise the 40th Anniversary of The Duke of Edinburgh's Award in Australia with special guest HRH, The Prince Edward. This opportunity led to me being contracted to the Asia Pacific team as the Award operated across 14 countries. I was responsible for rolling out regional campaigns and one that I designed and executed was nominated as the best communications strategy in the Award world (it operates in most countries around the world). I was

then invited by the London Office to manage several major global projects – again, mostly all from my little office in the Blue Mountains, NSW where I live, flying to where I was needed.

And then, another call from the Chairman of the Award in Australia asking would I be interested in becoming the National CEO of The Duke of Edinburgh's Award in Australia. I just laughed. A lot, until I realised, he was serious. I said yes and became the national CEO for exactly 5 years to the day. This job was a dream, thousands of 'pinch me' moments, but it was hard and relentless. We had the highest growth period the Award had experienced over the previous decades during those five years and the privilege of what I experienced working with the Royal Family, a global organisation and extraordinary young people - was never, ever lost on me.

I stepped down from this role for a few reasons. I had spent a lot of those five years in a plane. I wanted to be with my husband and my two children who were about to go to high school. I was at that point, 45 years old, and I strongly believed that a dynamic youth program needed a younger face. I wanted to make room for that person.

I also came to learn what sort of CEO I was and there are two kinds, I think. You are a Consolidator, or you are a Change Agent. I am the latter. I like building, I like innovation and I love developing and implementing new large-scale strategies.

I had introduced national programs in the role which today are still in place – but the organisation needed to consolidate these programs to ensure success, so they required a different kind of leader.

I leapt.

annoying voice inside urging me to learn how Australian politics really worked – on the ground - so when I left The Duke of Ed, I

I also had this growing, rather

officially joined the Labor Party, and I got my hands dirty volunteering on two election campaigns – one State and one Federal – and I was the Director of Fundraising. These were 'candidate' campaigns – meaning these people were not in government already. Reasonably complex stuff to change an electorates voting direction. I worked in these volunteer roles as hard as I would if I had been paid. Luckily, I then joined as a paid Director and worked on another two successful campaigns where our candidates were voted in....and it was here, that I met the person who would ring me out of the blue one day to say the Asbestos Diseases Research Institute (then named ADRI) was looking for someone to head up their Philanthropy Program.

With zero experience in the asbestos space, I leapt again and said yes.

After a year in that role, I was approached to take on the CEO role. Growing the visibility of good causes is about identifying the story, the why,

the point of

difference energises my work as CEO of ADDRI, motivates me through my board member roles, and pushes me to maintain an ethical and strategic focus. I have also been lucky enough to work with some of the most passionate and driven people in this space. I have learnt a lot and am grateful to each of them for their wisdom and generosity.

I believe in giving back and serving communities and if you are all things to all people, then you are nothing to anyone. I believe that sentiment, and that's why I'm unapologetic and clear about what ADDRI stands for and what we are fighting towards.

ADDRI is doing exceptional work to improve the diagnosis and treatment options for mesothelioma, silicosis and asbestos-related diseases here and around the world.

I trust that our legacy will be that we successfully unlock better, less invasive and lifesaving treatments because the horrendous legacy of asbestos usage in the world will be with us for decades to come.



Working on New Consensus Based Australian Guidelines for the Diagnosis and Treatment of Pleural Mesothelioma

ADDRI has assembled a national team of the world's leading mesothelioma experts to write the New consensus based Australian Clinical Guidelines for the Diagnosis and Treatment of Pleural Mesothelioma. The last guidelines were published in 2013 and a lot has changed. Chair Professor Sonja Klebe and ADDRI Academic and Research Director Dr Anthony Linton will lead the development of this updated document to bring the latest organisation and evidence-based approaches to the diagnostic assessment process for pleural mesothelioma, and to

enable tailored treatments for patients. The incredible first workshop was held at ADDRI on Monday 15th July – Vicki stated that you could feel the enthusiasm in the room and the collaboration was energic – the first meeting produced some really good thoughts and processes on the treatment of Pleural Mesothelioma into the future Below are pictured those who attended in person but there were many on line as well.

The International speakers were so varied and informative about what was happening in their neck of the woods and how they were tackling asbestos in their respective countries. ASBESTOS 2024 – Sustaining Innovation – explored new ways to manage, remove and dispose of ageing asbestos containing materials as well as innovations in diagnosing and treating



asbestos-related illnesses. It consider how the industry would identify and manage other elongated mineral particles being more widely found in the natural environment.

This significant event included a series of concurrent streams, technical sessions, international speakers, panel discussions and social functions.

Additionally, a large exhibition hall showcased a host of industry suppliers, proving unique opportunities for networking throughout the conference, including during the welcome drinks commencing on Sunday evening.

ASBESTOS 2024 was for anyone in the asbestos management industry, remediation, risk management and who are from the front line through to developing regulatory policy and for support groups who are always dealing with the health issues and the awareness issues around this whole area.

HAZELWOOD PROJECTS REHABILITATION

ENGIE UPDATE 2024

Landfill works progressing

Works to close and cap the former Hazelwood Ash Pond 1 (HAP1) are well underway.

The former ash pond was repurposed as an EPA-licensed asbestos landfill during the Hazelwood Rehabilitation Project demolition program. Any material contaminated with or likely to be contaminated with asbestos was safely moved to the landfill, which is less than a kilometre from the former power station block.

Now that all of the asbestos-type materials have been removed from the site, the landfill has been closed and the capping process is underway.

Large amounts of cover material have been transported to the area, to ensure the correct materials are used and to supplement material taken from on-site borrow pits.

The landfill will have a BEPM (Best Environmental Practice Method) cap. which includes clay capping, a geofabric sown down with grasses.

The adjoining area on the south east side of the EOD is also undergoing significant earthworks to improve drainage.

A further 12 to 18 months of work is required in this area, while monitoring will continue for a number of decades. With photo: Earthworks at the former HAP1. A mix of cover materials have been used to ensure a BEPM cap.

Long term revegetation program starts at Hazelwood

A long-term program of revegetating a large section of the Hazelwood Rehabilitation Project site has just kicked off.

Over the next six years it is expected nearly than half a million plants will be planted out across the Eastern Overburden Dump (EOD), the area where overburden was placed when excavated from the former Hazelwood

liner and more capping, until topsoil is mine at Morwell. The EOD is on the eastern side of the Rehabilitation Project site, and is bounded by Monash Way, the road from Morwell to Churchill.

> The focus in the first year is on the northern section of the EOD, with 65,925 plants. An appropriate mix of plants has been identified through a Revegetation Project Planting Plan.

> They include blackwood, wattles, spear-grass, acacias, various gums and wallaby and kangaroo grasses.

> Of note is the critically endangered Matted Flax-lily (Dianella amoena), and the Yarra gum (Eucalyptus yarraensis).

> Overall plantings will be arranged to compose three different vegetation communities, Sparse Woodland, Dense Woodland and Grassy Forest. Each will attract and provide habitat for different fauna.

> The revegetation works have been informed by extensive water management investigations and various studies completed between 2018 and 2021.

> The work will add habitat for native wildlife, while a 25 metre firebreak will remain unplanted through the centre of the zone.

Hazelwood Rehabilitation Project **Environmental Officer Oscar Aliotta** inspects the first batch of tube seedlings that will be used in the revegetation program.

ENGIE's Project Director of the Hazelwood Rehabilitation Project, Tom McDowall, said a local company has been engaged to manage the works, with a focus on local workforce participation.

"We are keen to continue to provide work opportunities and experience for local people," he said. "Programs such as these demonstrate the local skills required on rehabilitation projects such as at Hazelwood and possibly at other brown coal sites across the Latrobe Valley in the coming decades."

The scope of services required to undertake revegetation is extensive, and includes nursery propagation, preparatory groundworks for planting, planting and on-going monitoring and maintenance of planted vegetation.








Asbestos locations diagram

B. Bathroom, toilet and laundry

Wall and ceiling panels, vinyl floor tiles and backing for wall tiles.

C. Kitchen
